8 Juries will be formed by concert performers, conductors and conservatory teachers, musical operators, musicologists, and journalists in the field

- **9** The examining board's judgement, which is in any case the final one, will be expressed as hundreths. Frist Prize will thereby go to participants receiving from 95 to 100 points, Second Prize will go to participants with 90 to 94 points, THIRD PRIZE will go to participants with 80 to 89 points, diploma of meritwill go to participants with 75 to 79 points.
- 10 The winners among the participants in attendance, shall take part free of charge in the prize-giving concert to be held in Cortemilia on Sunday 28 April, under penalty of forfeiting the prize, and will not be entitled to any compensation for any filming or television recordings made during the concert.
- 11 Participants will be admitted to the trials in alphabetical order. The trial calendar will be published on the website www.comunecortemilia.it by the 12th April 2024.
- 12 Prizes_Among the first prizes, 5 concerts will be awarded, at the sole discretion of the Jury, to be held in the 2024/2025 season at the following venues:

2 in Cortemilia, by the Associazione Antidogma Musica

1 in Albisola, by the Associazione Orchestra Sinfonica di Savona.
